



This, our inaugural year, has been an exciting one for the Gateways Hospital and Mental Health Center Foundation. Our Articles of Incorporation were accepted by the State of California in July 2022. We held our first "official" Foundation Board meeting in September and received our 501(c)(3) status in April of 2023. The formation of our new Foundation took a leap of faith by the Hospital Board of Directors and our executive leaders. We are very appreciative of their support.

We are most proud of the Foundation Board Members who have stepped up and jumped right in. Our Foundation Board has introduced Gateways Hospital to community, business, and political leaders. Whether these leaders have provided letters of support for grant requests, taken tours of Gateways Hospital, or helped us launch new initiatives, we would not have been able to do this without Foundation Board member's introductions.

Speaking of new initiatives, Gateways Hospital will be expanding. We are thrilled to share our plans to expand and add 40 adolescent inpatient beds on the Effie campus. This expansion is made possible by a \$19,256,655 grant through the Behavioral Health Continuum Infrastructure Program, (BHCIP). This unit will provide mental health services for at-risk adolescents coping with gender identification issues, eating disorders, and co-occurring substance abuse and addiction.

We look forward to sharing more information with you in the coming months, and we are pleased to share our Community Report for FY 23.

Workforce Development

MIP CONREP— Gateways Hospital secured a second Mentored Intern Program grant of \$500,000 for our Conditional Release Program. Gateways’ CONREP program is the single largest provider of mental health and SUD recovery services for a niche class of justice system-involved individuals in Los Angeles County.

Working with California Lutheran University, Alliant International University, California Baptist University, and other local universities and colleges, Gateways’ CONREP provides a pipeline of qualified students eager to experience the clinical opportunities we provide to justice-involved individuals. Funds will support 5 clinical staff positions to serve as Mentors for 9 undergraduate, Masters level and post-doctoral students as they complete their course work and practical experience and enter the mental health workforce.

MIP Inpatient— Gateways was also awarded a second MIP program grant (\$336,000) for its Inpatient Psychology interns. A second

and third cohort of interns and practicum students will be working with some of our more fragile populations. Clinical Psychologists will mentor these students who have a strong interest in working with inpatient adolescents and adults.

HCAi— The California Department of Health Care Access and Information (HCAi) has awarded Gateways Hospital \$1,168,125 for its Community Based Organization Behavioral Health Workforce Agreement to encourage clinicians to enter and stay in the behavioral health workforce. This program provides loan repayment and retention bonuses for clinical staff who need assistance to repay their student loans and who agree to remain employed at Gateways for a number of years. This program also provides retention bonuses to clinical staff who have worked 5 years or more at Gateways.

Gateways and HCAi are committed to increasing the number of qualified individuals entering/remaining in the Behavioral Health and Substance Use Disorder workforce.

BHCIP Adolescent Expansion

Gateways Hospital and Mental Health Center will be expanding its inpatient capacity through a \$19,256,659 grant to build 40 adolescent beds at the Effie Street Hospital. The Hospital currently serves an average of 1,700 individuals each year, including a total of more than 525 adult and adolescent inpatients presenting with Severe Mental Illness and co-occurring Substance Use Disorder. This project ensures the availability of safe, needs-sensitive care for a burgeoning adolescent population. These beds will serve to meet the needs of

adolescents who identify as transgender, intersex, and nonbinary, those who are facing crises due to issues surrounding substance abuse and eating disorders, plus Transition Age Youth (TAY) who face increased pressure and placement issues as they transition to adulthood.

We are currently in the design and pre-construction phase with an estimated groundbreaking in early 2025 and completion by June 2027.

Hearst Foundation Trauma Informed Care and Cal OES Domestic Violence

A\$75,000 grant from the Hearst Foundations brought a training and implementation program for Trauma-Informed Care and Adverse Childhood Experiences (ACEs) to Gateways Hospital's adolescent unit. A total of 69 inpatient psychiatry staff members completed the Trauma-Informed Organizational Assessment (TIOA) survey, and we registered for nursing and psychology continuing education credits with the American Psychological Association and the California Board of Registered Nursing.

We screened 103 patients for ACEs with 56% of those screened (n=58) having 4 or more ACEs, and 30% who were newly diagnosed with PTSD during hospitalization. These screening tools allowed us to identify high-ACEs youth who had undiagnosed posttraumatic stress disorder, and to make referrals to community-based mental health care for treatment upon discharge.

Cal OES Domestic Violence Grant

Gateways' Adolescent Outpatient Program secured \$65,000 in funding over two years from the Domestic Violence American Rescue Plan Program of the California Governor's Office of Emergency Services (Cal OES) to ensure, particularly during COVID, that those without transportation or the ability to pay for public transit will be able to leave a dangerous or fraught situation and come to the hospital to obtain counseling and related domestic violence services.

The program to date has provided 882 trips through UBER Health, helping domestic violence victims and their families gain access to services to alleviate the trauma caused by domestic violence and promote healing.



Who Supported Us:


