

Gateways Hospital and Mental Health Center (GWHMC) has been providing Greater Los Angeles with comprehensive mental health services since 1953. Many of our patients and clients are experiencing chronic homelessness and are unable to access benefits of any kind. Mental illness affects almost one in four people in America. It changes family relationships, and according to the National Alliance of Mental Illness, 46% of people who die by suicide had a known mental illness.

Prior to the pandemic, the Gateways Hospital Board of Directors identified philanthropy as a key focus for the organization. We needed to engage the community and drive change in mental health. The best way for that to happen was to create a new foundation, take risks and be bold.

Gateways Launches Behavioral Health Mentored Internship Program with \$500,000 Grant from DHCS

In Spring 2022, under the direction of Dr. Elizabeth Morris, Psy.D., Director of Psychology, Gateways Hospital and Mental Health Center launched its Behavioral Health Mentored Internship Program. Made possible through a \$500,000 grant from the California Department of Health Care Services (DHCS) and Advocates for Human Potential, Inc., (AHP), the Behavioral Health Mentored Internship Program (BHMIP) operates as a complement to Gateways' robust Internship Program. Gateways currently has 60 practicum level, intern and postdoctoral students with the opportunity to treat patients of all ages. Our interns are trained


in the administration and interpretation of psychological assessments. Over an 18-month period, BHMIP will provide four groups of eight interns with 10 hours of mentorship per week at a ratio of one mentor to every two BHMIP interns. The

program also increases the stipend provided to each intern, helping to attract a greater number of exceptionally qualified and eager students to our Internship Program.

BHMIP was established with recognition that the incidence of severe mental illness has significantly increased during the pandemic, creating a current and future shortfall of behavioral health care providers. The program is designed to both attract candidates to the mental health field and to ensure that individuals entering the medical workforce are highly trained and prepared to address increasingly complex mental health issues.

"This is an exciting opportunity to provide the next generation of care providers with an in-depth introduction to the mental health field, says Dr. Morris. "It elevates Gateways' Internship Program and further establishes our reputation as a premiere teaching hospital for mental health professionals."



Riding High with QueensCare

QueensCare provided Gateways Hospital and Mental Health Center with a generous grant of \$75,000 in support of our Transportation Program, which provides free transportation to individuals entering and exiting our Adolescent and Adult Inpatient Program, and transportation to and from critical off-site appointments – including healthcare clinic visits, dental care visits and other mental health care services – for adults in our Normandie Village Residential Facility.

In the six months since funding was granted, Gateways has provided 89 trips to Normandie Village residents accessing primary care and has provided 32 rides to and from its Inpatient facility through UBER HEALTH.

The grant also empowered Gateways to purchase a multi-passenger van for use by Gateways staff at Normandie Village. The purchase of this van will ensure safe transportation to essential health care appointments and activities for Normandie Village residents for years to come.

Gateways Inaugural Golf Classic Gets a Hole in One

Gateways Hospital and Mental Health Center was pleased to host its first Annual Golf Classic at Braemar Country Club in Tarzana. The inaugural event was supported by more than 110 golf enthusiasts and an additional 35 dinner guests. In total, the event raised \$162,000 in support of programs and services provided by Gateways.

Gateways Receives State Funding to Enhance the Physical Security of Main Hospital Building

Gateways Hospital and Mental Health Center was awarded \$200,000 by the California Governor's Office of Emergency Services (Cal OES) to strengthen the security of its Main Hospital Building on Effie Street in Los Angeles.



The funding, part of the state's competitive Nonprofit Security Grant Program (NSGP), is based on a similar program administered by FEMA in the U.S. Department of Homeland Security. Both the federal and state NSGP programs are designed to assist high profile 501(c)(3) nonprofit organizations increase the physical security of their facilities.

Gateways will be utilizing the grant funds to purchase new equipment to enhance the safety of the individuals for whom Gateways provides care, their families, and the Gateways personnel

who work in the hospital and traverse its campus. Specifically, the hospital will invest in an advanced access control system to ensure that those who come to Gateways and seek either to enter or exit the hospital are authorized to do so.

According to California state officials, two key goals of NSGP funding are to promote the coordination of emergency preparedness between public entities and private communities, as well as build greater collaboration between state and local governments in pursuit of increased preparedness. Gateways is pleased to be a part of these efforts and pledges to work with its neighbors, as well as with its state and local governments, to support the enhancement of emergency preparedness, including in and near its hospital in Los Angeles.

The Ahmanson Foundation Supports Gateways' Efforts to Reduce Suicide and Self-Harm


The National Council for Behavioral Health reports that the number of individuals experiencing mental health issues has steadily increased over the last 18 months. The rise in crippling depression and other illnesses can be attributed in part to stress and fears related to the Covid-19 pandemic and to the volatile economy.

Along parallel lines, the number of individuals with severe mental illness – patients who are hospitalized because they have been deemed a danger to themselves and/or others – has also increased, as has the severity of their conditions. Tragically, along with such increases, behavioral health providers have seen a steady rise in the number of patients expressing suicidal ideation and attempting to harm themselves and/or fellow patients and staff members.

Gateways' foremost responsibility lies in providing a safe environment for its patients and staff. Understanding that patient bathrooms and bedrooms are the most frequently reported locations for suicides and self-harm, and that hanging is the most frequent method of suicide, Gateways has committed itself to renovating the bathrooms and bedrooms of its inpatient facility to create a safe environment and to meet the revised ligature guidelines instituted by the Centers for Medicare & Medicaid Services.

The Ahmanson Foundation has provided Gateways with a significant grant to support these efforts, which include the replacement of multiple sinks, faucets, toilets, hooks, and other hardware, and the replacement of patient beds and dressers with ligature resistant furniture. Through this grant, Gateways is confident it will reduce the risk of suicide and self-harm among our patients, creating a safe and beneficial environment for our patients and our staff.




